PARKING OPTIONS

There is FREE parking for council members adjacent to the KPERS building for those attending the full day. Access to parking is at 612 Jackson Avenue. The building manager will have the parking garage open from 8:30 to 9:00am and then again from 3:00pm to 3:45pm. Council members should park on the upper most level (outside) where their weatherization trucks are parked. If you plan on arriving after 9 AM or leaving prior to 3 PM then this parking option is not available.

There is FREE parking for guests at Bank of America parking garage located at 543 S. Kansas Avenue. You will need to bring your parking slip with you to the meeting and have it validated by KDADS. Otherwise, you will be assessed a parking fee in accordance with their hourly rates.

There is FREE parking across from the Eisenhower building on 7th, in lot 8c. Call Kathleen Williams with Capitol City Police 296-5191 fax 368-6307. You will need to fax Kathleen your name and Tag # if you wish to park there (this is about 3 blocks away from Jayhawk Tower).

There is meter parking on Jackson and on 7th. You can call City of Topeka at 368-3916 to have a meter bagged for \$6.00. The meters on Jackson at all even numbers 2-18 and on 7th are odd 7-27.

There is also a parking garage by Celtic Fox, and I believe it is \$1.00 an hour (8th Street between Jackson and Kansas Avenue).
