HCBS Amendments

The Centers for Medicare and Medicaid Services (CMS) issued a final rule for home and community-based setting (HCBS) effective March 17, 2014. All states must meet new requirements for home and community-based services and supports offered in provider owned and controlled residential and non-residential settings for those who are served by HCBS Program.

In these sessions, information will be shared that may have impact on the following programs:

- Autism (Time of diagnosis through 5 years of age)**
- Technology Assisted (0 through 21 years)**
- Serious Emotional Disturbance (0-18 years)**

These changes may impact:

- Where HCBS services can be provided
- Limitations on guardianship roles and responsibilities
- Person-centered plan of care development
- What changes are being proposed for each program
- Conflict-Free case management
