This IM transmits the allocation of contributions made by Kansans from their 2013 income tax to the Senior Citizens Meals on Wheels Contribution Program. These funds shall be used solely for the purpose of providing meals to seniors in their homes.

The funds are allocated to providers of home delivered nutrition services funded under Area Plans on Aging for the budget year September 30, 2014 -- September 30, 2015. The allocation percent of each provider is its percent of the total home delivered meals provided Kansas seniors during the area plan budget period that ended September 30, 2014.

To apply for these funds, submit an area plan revision on or before July 1, 2015.
