# Long Term Care: COVID 19 Testing Status Report Overview

The Kansas Department for Aging and Disability Services (KDADS) and The Kansas Department of Health and Environment (KDHE) are allocating lab resources to Nursing Homes and Long-Term Care facilities to support with and provide state funded COVID-19 screening tests through the [Kansas COVID-19 Unified Testing Strategy](#) effort announced by Governor Kelly. Through that effort, KDADS and KDHE have amassed several data points to build an initial view of the status of access to COVID-19 testing for staff across the 700+ KDADS licensed facilities.

Intent of the status report is to provide public awareness to such a critical public health issue, and to encourage facilities that need further assistance in accessing resources to regularly test their personnel (and as desired, their residents) to reach out to KDADS and KDHE for more information.

## Data Sources

- Direct report from Kansas state contracted labs: Identified all facilities the labs are currently contracted with **[As of December 4, 2020]**
- Survey responses from corporate leaders of Long-Term Care chains issued by KDADS: Indicated if their facilities were or were not regularly testing staff **[As of December 2, 2020]**
- Direct call outreach targeting primarily non-CMS certified Long-Term Care facilities: Indicated if they were or were not regularly testing staff **[As of November 23 and 24, 2020]**
- [CMS COVID-19 Nursing Home Data Set](#): Proxy data source that indicated CMS facilities that "tested asymptomatic staff and/or personnel without known exposure as surveillance" per week through week of November 15. **[As of November 21, 2020]**
- Survey responses received from Adult Care Home Facilities issued by KDADS: Indicated if they were currently conducting screening test of staff **[As of November 9, 2020]**

## Methodology

- Primary confirmation: Facilities that were identified as having access to test or not test their staff from either the direct report from Kansas state contracted labs, either of the KDADS issued surveys or the direct call outreach. If no information from either of these sources, then a secondary proxy confirmation was used (below).
- Secondary proxy confirmation: Facilities that were "testing asymptomatic staff and/or personnel without known exposure as surveillance" in at least 2 of 3 weeks in November per the CMS COVID-19 Nursing Home Data Set.

# Facility Type Abbreviation Definitions

- **Accredited Psychiatric Hospital (Accredited Hosp / Psych):** Accredited Psychiatric Hospital
- **Adult Day Care (ADC):** Facility operating less than 24 hours a day caring for individuals not related within the third degree of relationship to the operator or owner by blood or marriage
- **Assisted Living Facility (ALF):** Place or facility caring for six or more individuals not related within the third degree of relationship to the administrator, operator or owner by blood or marriage
- **Boarding Care Home (BCH):** Facility operating 24 hours a day, seven days a week, caring for not more than 10 individuals not related within the third degree of relationship to the operator or owner by blood or marriage
- **Hospital with a Psychiatric Certification (Hospital / Psychiatric CERT):** Hospitals with a psychiatric component licensed by Kansas
- **Home Plus (HP):** Facility caring for not more than 12 individuals not related within the third degree of relationship to the operator or owner by blood or marriage
- **Intermediate Care Facility for people with Intellectual disabilities (ICF / IID):** Facility operating 24 hours a day, seven days a week, caring for four or more individuals not related within the third degree of relationship to the administrator or owner by blood or marriage
- **Non-Accredited LTC Hospital:** Non-Accredited Long-term care hospital
- **Nursing Facilities (NF (State Only)):** Nursing facilities that only receive direct funding from the state
- **Nursing Facilities Long Term Care Unit (NF Only LTCU):** Hospitals with a distinct part dedicated to long term care residents
- **Residential Health Care Facility (RHCF):** Facility, or a contiguous portion of a place or facility, caring for six or more individuals not related within the third degree of relationship to the administrator, operator or owner by blood or marriage
- **Skilled Nursing Facility only certified for Medicaid (SNF Only NH):** Nursing facilities that are certified for Medicaid
- **Skilled Nursing Facility/Nursing Home (SNF/NF DISTINCT PART):** Nursing homes that are dually certified, but also have other licensure types at their facilities such as assisted living
- **Skilled Nursing Facility/Nursing Home (SNF/NF DUAL CERT):** Nursing facilities that are certified for Medicaid

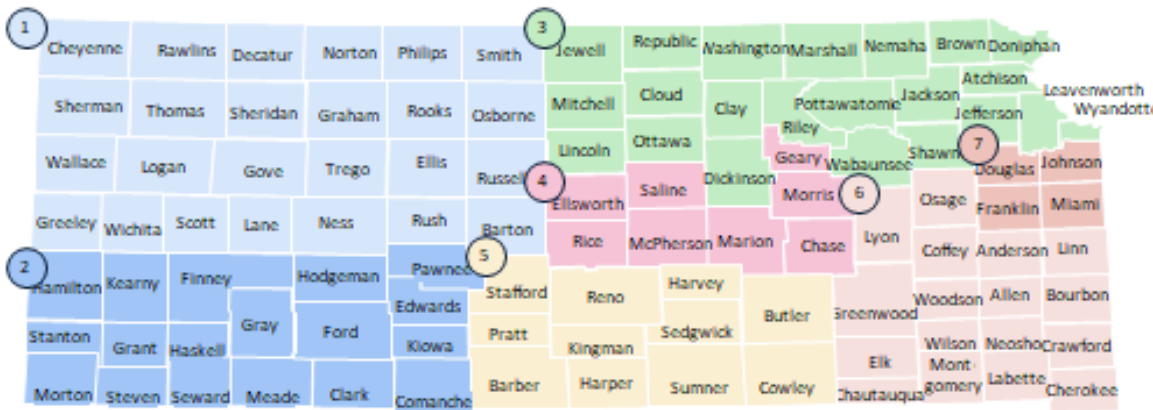

  - Please note that starting 12/21, KHEL will be switching over to a multiplex test that covers both COVID-19 and Flu A+B. This test will be administered via nasopharyngeal swab

# Unified Testing Strategy FAQs [I/II]

Will long term care facilities have to cancel their current agreements with laboratories and replace them with the state contract?

- For Facilities: If you already have a contract in place with a lab, you can keep using your lab, however, the state will only cover tests from the following labs
  - 4M
  - Clinical Reference Lab
  - MAWD
  - NicUSA
  - Quest
  - Sinochips
  - University of Kansas
  - Wellhealth
  - Wichita State University

What if I have an existing contract with a state contracted vendor that hasn't been assigned to my county?

- If your existing contract is with one of our State contracted labs, then the tests will be free. Please contact your lab to ensure they are aware. If your existing contract is **not** with one of our State contracted labs, you do not have to switch labs, but tests will only be free from one of our State contracted labs

Does 4M still need to set up a purchase order (PO), before they can start testing with facilities?

- 4M has been set up with a PO and is immediately ready to start testing facilities. Please reach out to them to get the logistics set up as soon as possible

What is the expected turnaround time for these PCR tests?

- All labs must process results in <48hrs of receipt of test. Please reach out to [KDADS.reopening@ks.gov](mailto:KDADS.reopening@ks.gov) if results are taking longer to process

How should long term care facilities continue to use point of care antigen tests now that the state contracted labs are available?

- Facilities who are already using antigen tests for screening can use PCR tests in conjunction with antigen tests. Example uses are; as back up supply, replace antigen tests with PCR tests for screening, or use PCR tests as confirmatory tests of positive antigen tests

Do the tests at the state contracted labs require a physician's order?

- No, the state offered COVID-19 tests do not require a physician's order

# Unified Testing Strategy FAQs [I/II]

Is there a charge from the state contracted labs if tests need to be conducted for adult care home staff members or residents?

- No, there is no charge from the state for conducting tests of adult care home staff members or residents. Please note, not all our labs have the capability to conduct tests at adult care homes. If you do not have this capability and your vendor lab cannot support you, please contact us at [KDADS.reopening@ks.gov](mailto:KDADS.reopening@ks.gov) for further support

When will the contracted labs start accepting samples from long term care facilities?

- Contracted labs can start accepting samples immediately. Please contact your associated lab to set up a one-on-one call and schedule the logistics of your testing.

Are facilities responsible for reporting the test results from the contracted labs to KDHE?

- If using a contracted State lab, facilities do not need to report test result to KDHE. We will use reports from the contracted State lab, so no need for the facility to also report

Can we opt into this process later or are we required to engage vendors now?

- The process is optional, but we encourage setting up the logistics now to ease the onboarding process with vendors

Can we receive PCR tests to have on hand, to administer after a positive antigen test result?

- Yes, you can use the contracted labs to receive PCR tests to have on hand

Do facility nurses need to complete a training to be able to administer the PCR tests?

- No, facility nurses do not have to complete additional training to administer tests. If nurses want a refresher on administering tests, please refer to the following training video [\[Training Video Link\]](#)

If both lab and facility report positive cases, will that be a double count toward the facility?

- If using a contracted State lab, facilities do not need to report test result to KDHE. We will use reports from the contracted State lab, so no need for the facility to also report

Will tests through Cytocheck also be free?

- No, while they are affiliated with MAWD, Cytocheck is not one of our State contracted labs and as such, tests conducted with Cytocheck will not be covered by the State
