

# **Pre-Admission Screening and Resident Review (PASRR) Processes**

## **Level I Assessments Frequently Asked Questions**



Area Agencies on Aging (AAA) have up to 5 days to complete the Level I assessments.

Level I Assessment to determine if the person meets the <u>physical needs for a nursing home</u> and whether there is a need for further evaluation (Level II evaluation referral) due to mental illness and/or intellectual/developmental disability.

#### 1. When is a Level I Assessment required?

- a. All individuals 16 or older, regardless of race, national origin, color, sex, disability, or religion, who are seeking entry to a <u>Medicaid-certified nursing facility or long-term care unit</u>, must have either a Special Admission or a Level I to enter.
- b. Before the Special Admission ends and the person is still in care, a Level I Assessment will be needed.
- c. Transfers from one facility to another do not require a new Level I Assessment unless the person did not have a Level I Assessment in the past.

#### 2. Does the payor source matter?

No, the payor source does not matter. Everyone must have a have either a Special Admission or a Level I to enter. Eventually, KDADS will expect all people entering a nursing facility or long-term care unit to have a <u>Level I Assessment prior to</u> entry.

# 3. What happens if the person enters the facility and there is no Special Admission or Level I Assessment on file?

It is the facilities responsibility to make sure that the appropriate admission information is on file and submitted to the KDADS CARE Team for each admission.

- a. The facility should contact the AAA in their area as soon as possible to get a Level I assessment scheduled.
- b. If the person is already in the facility, the facility should submit documentation of the request for the Level I Assessment to KDADS with the fax cover sheet for coverage of the time between the request to the AAA and the completion of the Level I Assessment.
- c. AAAs have up to 5 days to complete the Level I Assessment.

### 4. What happens if the person already has a Level I Assessment?

A Level I assessment allows a person who meets the level of care required for an NF to choose to enter an NF at any time after the assessment up to **365 days** (1 year after the date of the assessment).

5. How to send appropriate documentation to the KDADS Care Team?
