MFEI Background

<u>Medicaid Functional Eligibility Instrument</u>

- The Medicaid Functional Eligibility Instrument Level of Care (MFEI-LOC) will be used to determine functional eligibility and care needs for long term services and supports (LTSS) to meet federal Medicaid eligibility requirements
- Beginning August 12, 2019, the MFEI-LOC will be used for:
 - HCBS-BI (Home and Community Based Services Brain Injury) (adult only)
 - TBI Rehabilitation Facilities (adult only)
- The MFEI-LOC will replace the FAI for BI assessments.
- The MFEI-LOC is supported by software that works online and offline

interRAI Assessment Tools


- The MFEI is a universal suite of instruments based on the interRAI instruments
 - A universal core of common items is applicable across all populations
 - Population specific items are included via skip patterns
- State specific adaptions were applied to the base interRAI tool in collaboration with stakeholders

interRAI Assessment Tools

- There are multiple versions of the interRAI assessment being adapted for use in Kansas:
 - The full interRAI tools, with Kansas adaptations, will eventually be used by KanCare MCOs for careplanning
 - The MFEI-LOC is a portion of the interRAI Home Care (iHC), containing only items that are, or may be, relevant to functional eligibility. Used for:
 - HCBS-BI (adult only)
 - TBI Rehabilitation Facilities (adult only)
 - In the near future, the MFEI-LOC will also be used for:
 - HCBS-BI, youth
 - HCBS-FE (Frail Elderly)
 - HCBS-PD (Physical Disabilities)
 - PACE (Program of All-inclusive Care for the Elderly)
 - CARE (Comprehensive Assessment, Referral, and Evaluation)
 - Also working on IDD specific versions of the MFEI

interRAI Background

- Health and LTSS assessments designed by an international network of researchers and clinicians
- interRAI assessments have pre-established validity and reliability via the researchers and clinicians that developed the assessments
- The base assessments are maintained by interRAI
- interRAI tools have some overlap with the MDS assessment used in nursing facilities
- interRAI assessments are used by at least 20 other states and internationally
- interRAI assessments are designed to serve multiple purposes: 1) eligibility screening;
 2) careplanning; 3) quality assurance;
 4) case mix; and, 5) policy planning
- Technical assistance is available from interRAI and from other states using interRAI



MFEI-LOC Overview

- The MFEI-LOC is one assessment instrument, with skip patterns for the different programs
- Section I: Identification Information
- Section II: PASRR (CARE/NF only)
- Section III: Functional Assessment
 - Cognition; Communication and Vision
 - Mood and Behavior; Psychosocial Wellbeing
 - Functional Status (IADLs, ADLs, Mobility)
 - Continence; Health Conditions
 - Environmental Assessment
 - Social Supports (PD/FE/CARE only)
- Section IV: Services Recommended (CARE only)
