SED Waiver Attendant Care EVV Notice

In light of concerns regarding compliance with both the Cures Act for Personal Care Services (PCS) EVV and accuracy in Place of Service (POS) coding, the state of Kansas is prioritizing adherence to the Cures Act.

Therefore, as an interim measure, Kansas is adopting the POS code 99 to be utilized for all SED Attendant Care services only and is instructing all SED Waiver providers, which in this case are Community Mental Health Centers (CMHCs), to implement this system. Please note that this is a temporary solution to ensure compliance with the Cures Act EVV requirements while KDHE and KDADS work towards a permanent solution to meet both EVV and accurate POS coding standards.

This measure is aimed at mitigating concerns among CMHCs about the risk of non-compliance, with the state taking on the responsibility until a comprehensive solution is implemented.

CMHCs should begin submitting EVV claims for the code T1019HK on August 1, 2023.

When sending authorizations for SED Attendant Care, MCOs are to use the following CMHC KMMS IDs:
