



## A Message from Secretary Laura Howard

We have been in this pandemic now for more than six months and I am so aware of and grateful for the hard work that you and your teams are doing each day on the front lines. I know your focus is on the health and well-being of your residents, your teams and your organization. You're providing services in ways you've never dreamed of before this pandemic. You're showing creativity and innovation in keeping your residents healthy – and especially in keeping them connected to those who love and care about them. Your staff are learning new skills, multi-tasking even more than usual, and acting as responsible citizens to keep themselves healthy and able to continue supporting the residents they care so much about. As leaders, you are working across jurisdictions each day in



your response – local, state and federal and trying to keep up with changing guidance and policies, science and public health advice, and available recovery resources. You've had to develop and build new relationships. It's a lot to manage and juggle – individually and as organizations. You've shown extraordinary commitment and I honor you.

Here at KDADS and at the state, we have also been busy focused on how to best support you, your teams and those you serve. We have done our best to keep you informed, to communicate regularly, to provide guidance and to request and provide important supports. We have tried to be your voice at times with our federal partners as we navigate together this ever-changing environment. We appreciate the collaboration to make communications devices available to many of your facilities and to date have distributed 4,100. I am also pleased that our request for more than \$38 million for federally licensed facilities to support PPE, supplies and other needs was approved by the State Finance Council and that this funding is on its way to our federally licensed facilities.

The state's SPARK Committee and State Finance Council approved an additional \$10 million to support our state-licensed facilities with PPE and other supplies that can be ordered through a vendor contract - facilites can use our online ordering portal to directly purchase PPE and sanitizing supplies. We also appreciate how much KDHE and local health departments have stepped up to support all of you with public health advice and testing support in times of outbreaks. I also want to give a shout out to our emergency management partners at the Kansas Division of Emergency Management and locally, for emergency provision of PPE through our emergency management partners.

We continue to have challenges that we must navigate together. These include the new testing mandates from the Federal Center for Medicare and Medicaid Services. KDADS and KDHE are allocating lab resources to Nursing Homes and Long-Term Care facilities to support with and provide state funded COVID-19 screening tests through the Kansas COVID-19 Unified Testing Strategy effort announced by Governor Kelly. Through that effort, KDADS and KDHE have amassed several data points to build an initial view of the status of access to COVID-19 testing for staff across the 700+ KDADS licensed facilities.

Early in December, Governor Kelly issued Executive Order 20-69 intended to subject adult care homes that are exclusively regulated by the state to similar federal COVID-19 testing requirements as set out in QS0-20-38-NH.

I know you are also now planning for how to carefully and prudently open your doors in concert with new federal guidance and some guidance we also are issuing. We all know how important it is to support the physical and emotional health of your residents and their desire and need to connect with their loved ones. Thank you in advance for all the ways in which you will support this effort. It's time.

In closing to each and every one of you – you are the unsung heroes. With immense gratitude, I extend my appreciation and a sincere thank you for the compassionate around-the-clock care you provide to our most high-risk Kansans, especially during this pandemic.

## A Message from the Ombudsman

During the past nine months ombudsmen have been working to respond to questions and concerns about long-term care and specifically, COVID-19. While our complaints are slightly lower than usual, the number of consultations we have provided to both providers and to consumers in the past nine months has dramatically increased.

As you know, family and friends who are unable to see loved ones living in long-term care facilities because of the COVID-19 emergency may struggle with changes in protocol, rights and policies. The Kansas Long-Term Care Ombudsman Program is available to help with a statewide resource called Virtual Family Council.

The program offers bi-monthly online meetings with the State Long-Term Care Ombudsman. Anyone with a loved one can participate and ask questions, share concerns, or just listen to learn and gather information. The meetings will not address specific issues regarding a resident or a facility.

Family and friends who want to attend should email the Ombudsman program at LTCO@ks.gov and use 'Virtual Family Council' in the subject line to receive a meeting link and instructions. We ask that facilities continue to include in their messages to families about the availability of services from the Long-Term Care Ombudsman, and to let them know about our Virtual Family Council Meetings.

## CNA, CMA Courses During COVID-19

A memo created by CMS back in March provided nursing homes guidance for limiting the transmission of COVID-19. Within this guidance, CMS mentioned that facilities should restrict visitation of all visitors and non-essential health care personnel. Without having more clarification on how CNA/CMA students should be classified, schools were starting to have a harder time obtaining a clinical site for their students and resulted in a significant number of CNA/CMA courses to be halted. In order to have these courses to continue, KDADS approved exceptions to specific rules.

One exception allowed for the CNA/CMA required 25 hours of clinicals to be completed in a simulated lab instead of the required Adult Care Home setting. A simulated laboratory setting is defined in K.A.R. 26-50-10 as "an enclosed area in a school, institution, adult care home or other facility that is similar to an adult care home resident's room." This exception was recently extended from June 30, 2020 to March 31,2021, to allow Adult Care Homes time to adjust and implement their reopening phases.

To clarify, CDC identifies nursing students as healthcare workers. As such, KDADS would include nurse aid/medication aid students to fall within this definition. For 2020, KDADS Health Occupations Credentialing has approved 725 CNA courses, 313 CMA courses, and roughly 3,122 newly certified CNA's. "Thank you" to all approved CNA/CMA/HHA Instructors for continuing to provide proper training and our healthcare workers who selflessly continue to work to make sure the residents are top priority and receive the care they should.

## Updated Focused Infection Control Survey Process and Training Resources

According to the memo (QSO-20-38-NH) released on August 26, 2020, CMS provided information regarding the revised COVID-19 Focused Survey Tool. The purpose of the revision was to provide guidance for surveyors to assess compliance with the new testing requirements. The revision also directs surveyors to assess for compliance with designation of an infection preventionist (IP) who is responsible for the facility's infection prevention and control program (IPCP) at 42 CFR § 483.80(b). Noncompliance will be cited at F880.

Surveyors will ask for documentation of testing and will review the documentation for compliance with CMS guidance for staff and resident testing. Surveyors will also review records of sampled residents and staff to verify their testing procedures. If during the survey process testing is being done, the surveyors will observe the real-time testing procedures to assess if testing and specimen collection meets the current standards of practice. Surveyors also will observe for correct use of PPE in order to prevent transmission of the virus. If observation is not possible, interviews will be completed with staff responsible for testing. If a


shortage of testing supplies exists, then surveyors will ask for documentation to show the facility contacted state and local health departments or the county or state emergency management authorities to help with the shortage issues. If facilities are not in compliance with the testing requirements in § 483.80(h), the facility will be cited at F886.

Training resources are available for facilities on the QSEP (Quality, Safety, and Education Portal) website. The training includes modules designed for frontline workers as well as management staff. On the website homepage, the learner can click on a link for instructions on how to access the Targeted COVID-19 Training for Nursing Homes.

## **Surveying Other Long-Term Care Settings Amid a Pandemic**

State-licensed facility surveyors approached the legislative mandate to conduct infection control surveys in all facilities with a great deal of courage, enthusiasm and purpose. Our surveyors were anxious to get out and make sure all our licensees had policies in place that were being followed in order to hopefully prevent the spread of COVID-19. They covered a lot of miles in a short amount of time and discovered a lot.

The biggest concern found during the Infection Control Surveys was the lack of an adequate supply of PPE everywhere, but especially for many of our smaller facilities. We found that Home Plus facilities were often pushed aside or stepped over when trying to order PPE. The suppliers favored the larger companies with bigger orders.

The next outstanding concern was the certified staff's failure to follow the policies and procedures put in place by administration to help mitigate the spread. Many facilities did an outstanding job of encouraging their staff to comply with guidelines even when off duty. But for others, it was almost an act of futility to get some of their certified staff to keep their masks on when on-duty and entering resident rooms.

I was touched by the outpouring of concern for Kansas seniors all across the state as family members called and expressed their anger, frustration, and worry. The phone calls came from both sides: providers and family members as they expressed outrage and frustration over the sudden but necessary shut down of the facilities. Initially, our main concern was keeping the residents physically safe from COVID-19. Lock the doors! As time went on, however, we realized how impossible it was going to be to keep our seniors (along with their families), emotionally safe from COVID-19. It will take time to heal.

### **Survey Activity Post Infection Control Surveys**

Going forward, our surveyors will be continuing to investigate IJ and C-10 complaints onsite. We are also going back and conducting revisits for surveys that were done pre-COVID. Additionally, we are picking up the farthest out surveys to make sure those facilities are up to date and also performing initial surveys for newly licensed facilities.

## **Reporting COVID to NHSN**

With the release of CMS memo QSO-20-29-NH on May 8, 2020 all CMS certified Long-Term Care communities were required to start reporting data related to COVID-19 to the "National Healthcare Safety Network" (NHSN) tracking system. Some of the data that should be reporting includes suspected/confirmed residents and staff with COVID-19 infections, testing capability, PPE supply, staffing shortages and ventilator capability/numbers. Remember when reporting new cases of COVID-19 in both staff and residents, only count each case one time and do not continue to count the resident and/or staff member each day/week during the duration of their illness, including not rolling over information related to admissions and deaths (noting each of these instances should be counted only one time in reporting). Be sure to read all questions and answer them as they are asked to promote consistency with reporting.

According to CMS, data must be submitted at least weekly, although it may be submitted more frequently if that works better for your facility. Data must be submitted at least one time every 7 days and CMS will review submitted data on Monday every week. It is important to remain consistent with data submission and submit data on the same day or days each week.

Once data has been submitted within each pathway on the NSHN tracking system the pathway name should be represented in a green block on the calendar for the day submitted. Review the data to ensure each block turns green and stays green. If there is an error or missing information the block will turn tan, then review the information and correct any inconsistencies at that time. Accurate reporting to the NHSN tracking system helps monitor PPE amounts, determine the need for additional testing options, gather data to help formulate reopening/visitation plans in given areas and determine the need for additional staffing/education when shortages are identified. ## Surveying Nursing Homes Amid a Pandemic

We all are experiencing a wide range of emotions as we live our day-to-day lives during COVID-19. If that is not enough, we care for our Nursing Facility residents in the State of Kansas. I want to take a moment to say THANK YOU for all you are doing to keep the residents and your staff safe. This is not an easy job in this very uncertain time.

The Focused Infection Control Surveys (FICS) were started in March 2020. During this time, the state surveyors have written 10 deficiencies under the F880 tag scoped at an L, 1 at a K, 2 at a J and 46 at an F. The top 5 reasons deficiencies are being written are:

- Improper screening of staff and residents
- Improper use of PPE (Personal Protective Equipment)
- Improper cleaning of Isolation areas
- Improper cohorting of COVID and Non-COVID residents
- Lack of COVID education provided to staff

The CMS Targeted COVID-19 Training for Nursing Home Management is a great tool and addresses those top 5 areas. The training can be found at: https://qsep.cms.gov/COVID-Training-Instructions.aspx

The surveyors will still continue to complete complaints that are scoped as Immediate Jeopardy (IJ) or non-IJ high, re-visits for any facility with a removed IJ, surveys that are greater than 15 months and Special Focus Facility surveys as stated in the CMS Memo QSO-20-30-All. The survey staff will also complete the 2-day, 3-5-day FICS surveys that are sent to us weekly from CMS.

### Good Infection Control Practices With Respect To Physical Environment

Q: Are Infection control practices found in the construction regulations?

**A:** Infection Control is found within the construction regulations of each type of Adult Care Homes, in the Laundry section. Each type of Adult Care Home regulation may be worded a little different, but they all have the same basic concept. The facility must hold contaminated laundry safely and have a one-way flow in a laundry area; from dirty to clean.

### **NURSING FACILITIES**

*KAR 26-40-302*, Physical Environment; Applicants for Initial Licensure and New Construction. (g) Common rooms and support areas... (6) Laundry services.

Each nursing facility shall have the means for receiving, processing, and storing linen needed for resident care in a central laundry or off-site laundry, or both, or a personal laundry room located on a resident unit in combination with these options. The arrangement of laundry services shall provide for an orderly workflow from dirty to clean, to minimize cross-contamination.

*KAR 26-40-303*, Physical Environment; Existing Nursing Facilities (f) Common rooms and support areas... (8) Laundry services.

Each nursing facility shall have the means for receiving, processing, and storing linen needed for resident care in a central laundry or off-site laundry, or both, or a personal laundry room located on a resident unit in combination with these options. The arrangement of laundry services shall provide for an orderly workflow from dirty to clean, to minimize cross-contamination.

### ASSISTED LIVING/RESIDENTIAL HEALTH CARE FACILITIES

*KAR* 28-39-255. Support service areas. (c) Laundry facility.

- (1) The facility shall store soiled laundry in a manner which prevents odors and spread of disease.
- (2) If laundry is processed in the facility, the facility shall provide washing and drying machines. The facility shall arrange the work area to provide a "one-way flow" of laundry from a soiled area to a clean area.

### **HOME PLUS FACILITIES**

KAR 28-39-437. Construction; general requirements. (e) General building interior. (4) Laundry area.

- (A) If the facility processes laundry, the facility shall provide a work area with a one-way flow of laundry from a soiled area to a clean area.
- (B) The laundry area shall not be located in the same room where preparation and service of food occur.
- (C) Each facility shall store laundry in a manner that prevents odors and the spread of disease.

### **ADULT DAY CARE FACILITIES**

KAR 28-39-290. SUPPORT SERVICES AREAS. (c) Laundry facility.

- (1) If the facility processes laundry, the facility shall provide washing and drying machines. Each facility shall arrange the work area to provide a one-way flow of laundry from a soiled area to a clean area.
- (2) Each facility shall store soiled laundry in a manner that prevents odors and the spread of disease.
