RETENTION OF RECORDS

According to 26-41-105 [Kansas Secretary of State - KAR Regulations \(ks.gov\)](#) each operator will maintain resident records in accordance with acceptable standards of practice.



The facility must maintain discharged resident records for at least five years. If a facility is going thru Change of Ownership, it would be best practice to have a process in place to retain possession of records during the transfer. Power Strip Safety

As technology progresses, many of us find that there just are not enough outlets to manage all of our devices and appliances, especially in older buildings. Homes and workplaces alike often do not have an adequate number of electrical outlets. In addition, the outlets that exist are not always located in the most convenient place for our use.

Thankfully, power strips are here to save the day against this monumental adversary. However, it is important to take safety precautions when using power strips, especially with the holidays and colder weather right around the corner.

A crucial step to using power strips is to have knowledge of their amperage rating. This can be found on the tag located on the power cord or on the underside of the strip. It is important to note the amperage rating of the power strip and the devices that are being plugged into it. If you are not careful, the power strip will become overloaded, which can cause the power strip to overheat and may catch fire.

With cooler temperatures coming, many turn to using space heaters for warmth. An important rule to follow is plugging space heaters directly into a wall outlet. Power strips are not designed to handle the energy load of a space heater. This will likely cause the power strip to overheat, creating an increased risk of fire.

In addition, the following are best practices to stay safe when using power strips.

- Power strips are meant for indoor use only.
- Power strips should be plugged into a grounded wall outlet. Do not plug a power strip into an existing surge protector, power strip or extension cord.
- Power strip cords should not be passed through doors, walls, floors, or ceilings.
- There should only be one power strip or surge protector plugged into a double wall outlet.
- Only use power strips for low-voltage electronics.
- Keep all power strips and surge protectors uncovered so that air around it may circulate freely.
- Check power strips and surge protectors regularly to ensure they are not damaged.

While technology has produced some great products that make our lives easier, it is also very important to understand the safety risks. Following these tips can reduce the risk of fire due to the incorrect use of power strips.



State Operations Manual Appendix PP SOM, Rev. 211, 02-03-23, (F689, Accidents) :

Electrical Safety - Any electrical device, whether it needs to be plugged into an electric outlet, can become hazardous to the residents through improper use or improper maintenance. Electrical equipment such as electrical cords can become tripping hazards. Halogen lamps or heat lamps can cause burns or fires if not properly installed away from combustibles in the resident environment. The Life Safety Code prohibits the use of portable electrical space heaters in resident areas.

Power strips may not be used as a substitute for adequate electrical outlets in a facility. Power strips may be used for a computer, monitor, and printer. Power strips are not designed to be used with medical devices in patient care areas. Precautions needed if power strips are used include installing internal ground fault and over-current protection devices; preventing cords from becoming tripping hazards; and using power strips that are adequate for the number and types of devices used. Overload on any circuit can potentially cause overheating and fire. The use of ground fault circuit interruption (GFCIs) may be required in locations near water sources to prevent electrocution of staff or residents.

Community Partnership

On October 12, 2023, Kansas Department for Aging and Disability Services LTSS Commissioner Michele Heydon and Director of NF and ACH Programs Sheri Jurad traveled to Manhattan, KS to receive the Friend of the College Award on behalf of the KDADS NF Program Team for their collaboration with the PEAK program. The Friend of the College Award recognizes significant, ongoing support of the College of Health and Human Sciences. Award winners have demonstrated significant leadership on behalf of the college at the community, state and/or federal level.

KDADS has been a partner with the K-State Center on Aging for more than 10 years through contract work, which started with the Center providing educational materials to the organization about culture change in nursing homes. In 2012, KDADS contracted the Center to administer its Medicaid pay-for-performance program, PEAK, which is still housed in the Center today. This relationship has provided the opportunity for the Center to be seen as experts on person-centered care and large-scale change on both the statewide and national levels and has allowed them to impact the quality of life for residents in nursing homes across the country.

CMP Announces Grant Opportunity for Visitation Air Flow and Quality Improvement

As of Feb. 2, 2022, certified nursing facilities may apply for up to an additional \$3,000 of CMP Nursing Home Visitation Aid Grant funds for the purchase of indoor portable fans and/or indoor portable air cleaners with high-efficiency particulate air (HEPA, H-13, or -14) filters to increase or improve air quality for resident in-person visitation. MDS MINUTE

It has been a few weeks since CMS released the updated MDS item sets and RAI Manual v1.18.11 with a significant amount of changes. We are aware of the time and effort it takes to implement these kinds of changes within your facilities and appreciate the time and dedication that goes into an undertaking like this. I wanted to touch base with you all about a few questions I have received in multiples over the last few weeks.

1. Will Kansas require an Optional State Assessment?

- ◆ At this time Kansas is not requiring an optional state assessment.

2. What is the lookback period for some of the 10-01-23 MDS questions, if the RAI Manual does not specify?

- ◆ According to the RAI Manual the lookback period for all items is 7 days unless another time frame is indicated.

3. Is this item missing because of a software glitch?

- ◆ If you look up the specific item set (NC, NQ, etc.) on the CMS website you will be able to see if CMS intended for that specific question to be made available on your specified item set. If you note that the question/item should have been made available, please reach out to your software vendor to ensure all required areas are captured.

4. Where do I find MDS updates?

5. Do you have any information about ICD-10 coding or upcoming trainings?


